There will be a limited bar menu. We will be adding to the menu as time moves forward.

We are asking the Willamette Aerie 2081 members be the first to enjoy our new building. You may bring one guest to encourage them to become a member. You will not receive a door key until the we open to full capacity. Everyone will need to enter the building from the back of the building up the ramp. Ring the buzzer and the bartender will let you know if there is room for you to enter.

The lottery machines will be up and operating we will be following lottery's use of the machines. We will not be selling Power Ball, Mega Millions, Keno, Oregon Megabucks or Oregon Raffle tickets. Oregon

Lottery removed the machine that sells and validates the tickets, because of extremely low sales at location.

The members that paid their 2020-2021 dues will be entitled to their early bird drink tickets. All other drink tickets have expired and will not be accepted.

As Eagles we work on volunteers. You will need to bus your own tables. There will be a station for empty glasses to be returned.

We are looking for an entertainment committee to start getting charity events setup for the near future. We are looking for someone to start up the "Ace of Spades" (which was formerly the Queen of Hearts)

We are holding our regular scheduled meetings for the Aerie and Auxiliary.
